The items shall be sold to the bidder who will quote the consolidated the **highest rates**. The bids are invited for the whole lot (i.e. All the items lying in four Places in the campus. Some Main and Obsolete, condemned items as detailed at Annexure –I, as a whole) and No bid would be accepted for any part of the same.

Scope of work :

Disposal of unserviceable & obsolete items, these have been discarded and are no longer usable by this office.

Eligibility Criteria:

1. The bidder should deposit Rs. 3,00,000/- (Rupees Three lakhs only) as EMD in the form of an account Payee Demand Draft (DD) from a scheduled Bank in favour of the **Director ,ICAR-IIFSR, Modipuram, Meerut-250110 payable at Meerut and the same (in original) in an envelope will be submitted to OIC (Store), ICAR-IIFSR, Modipuram Meerut-250110** during the prescribed time, along with documents. EMD of the unsuccessful bidder shall be returned without interest at the earliest on finalization of the auction. The bid without EMD (in original) will be liable for rejection.
2. Copy of PAN No., GST No. & Aadhar Card /Address Proof, in the name of the proprietor /owner/firm company are required to be uploaded on the GeM Portal. The document to be uploaded should be legible. In case the uploaded documents are not readable, the bid cannot be examined, and the bid can be rejected.
3. In case of sale of hazardous, e-waste used oil , old lead acid batteries involving inter- state movement of goods, the buyer shall submit an NOC from the concerned state pollution control board with whom the buyer registered, to the seller before taking delivery, failing which the buyer will be responsible for the consequences and the seller shall take further decision as may be deemed fit.

Terms and conditions

1. The unserviceable material/items will be available on auction. The unserviceable material/ items can be inspected by the interested parties along with relevant documents as demanded in Bid on prescribed date from 22.01.2025 to 24.01.2025 between 10:00 AM to 1:00 PM by contacting the, OIC (Store), ICAR-IIFSR, Modipuram meerut-250110. No request for inspection after submission of the bid will be accepted.
2. The bid shall remain valid for 180 days after the date of bid opening. If any bidder withdraws his/her/ bid before the said period, this office shall without prejudice to any other right or remedy, be at liberty to forfeit the bid security absolutely.
3. The conditional bid shall not be entertained.
4. Evaluation criteria: the successful bidder will be the one which offers the highest total rate for the entire lot of scrap as (As is, where is, what is) Some Main and Obsolete, condemned items visible in lot as detailed at Annexure –I, as a whole, no part lifting of the item shall be allowed.
5. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the unserviceable material/items. Material/items.
6. The unserviceable material /items is to be lifted up within 10 days on the issue of release order on making full payment in the form of an account payee Demand Draft(DD) in favour of the **Director, ICAR-IIFSR, Modipuram meerut-250110**. Otherwise, the EMD money deposited will stand forfeited and the offer shall be awarded to the next eligible bidder on H-1 price if agreed.
7. The successful bidder must lift all the unserviceable material/items at his own cost. If the party fails to lift the auctioned items within the stipulated time or not make financial arrangement as per the schedule date, his EMD shall be forfeited, debarred from future tender/bidding and failing which the next bidder fails to do the above job, it shall also be debarred from future tender/bidding process.
8. The lifting of the items shall be done without damaging the premises/roads/ drains/etc. the buyer shall be done compensate the damages, loss, etc. in the event of any occurrence otherwise.
9. No selection or sorting whatsoever of the goods will be allowed. The entire lot should be cleared by getting a proper gate pass from ICAR-IIFSR, Modipuram meerut-250110.
10. Any unclear on un-notice material left over by the successful bidder within the premises cannot be claimed later.
11. No enquiry of the bidder shall be entertained once the material is lifted by them.
12. The materials being disposed of are to be treated in the line with applicable rules/notifications/guidelines etc. as may be prescribed by the government. The successful bidder shall be responsible to ensure this action.
