

Eligibility Criteria:

1. 2. Copy of PAN No., GST No. & Aadhar Card /Address Proof, in the name of the proprietor /owner/firm company are required to be uploaded on the GeM Portal. The document to be uploaded should be legible. In case the uploaded documents are not readable, the bid cannot be examined, and

at liberty to forfeit the bid security absolutely.

4. Evaluation criteria: the successful bidder will be the one which offers the highest total rate for the entire lot of scrap as (As is, where is, what is) Some Main and Obsolete, condemned items visible in lot as detailed at Annexure –I, as a whole, no part lifting of the item shall be allowed.

5. The undersigned will not entertain any claim for damage done by the way of theft, fire or any other unforeseen calamity after realizing full payment against the unserviceable material/items.

6. The unserviceable material /items is to be lifted up within 10 days on the issue of release order on making full payment in the form of an account payee Demand Draft(DD) in favour of the Director, ICAR-IIFSR, Modipuram meerut-250110. Otherwise, the EMD money deposited will stand forfeited and the offer shall be awarded to the next eligible bidder on H-1 price if agreed.

7. The successful bidder must lift all the unserviceable material/items at his own cost. If the party fails to lift the auctioned items within the stipulated time or not make financial arrangement as per the schedule date, his EMD shall be forfeited, debarred from future tender/bidding and failing which the next bidder fails to do the above job, it shall also be debarred from future tender/bidding process.

8. The lifting of the items shall be done without damaging the premises/roads/ drains/etc. the buyer

shall be done compensate the damages, loss, etc. in the event of any occurrence otherwise.

9. No selection or sorting whatsoever of the goods will be allowed. The entire lot should be cleared by getting a proper gate pass from ICAR-IIFSR, Modipuram meerut-250110.
